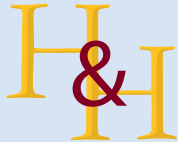

Be Careful Who You Talk To After An Accident

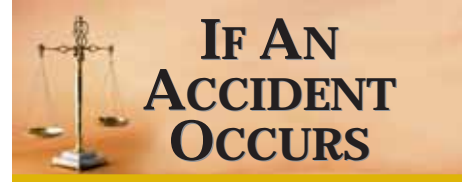
After an accident, you may be contacted by people who want to discuss it with you. Other than your family and your own doctors, it's often best not to discuss it with anyone except your lawyer (your insurance policy may require you to give a statement, but contact your lawyer before doing so). People wanting to discuss the accident may work for an insurer, and anything you say could hurt your claim.

Some accident victims receive less than full compensation because they say something that can be taken out of context and used against them later. Avoid problems by asking your lawyer if it's okay to give a statement.
